In response to the ever changing conditions of the COVID-19 virus, the Lyon County Board of Supervisors moved on March 19, 2020 to close the Lyon County public buildings to the public with the exception of the Law Enforcement Center, Public Health, and 3rd Floor Courtroom as of 8:00 a.m. on March 20, 2020 until further notice. The Lyon County Board of Supervisors are encouraging all residents to use online resources, email, and telephone calls to County Offices rather than in-person visits to any of Lyon County Government buildings. The Lyon County Board of Supervisors believe that the safety of all Lyon County residents as well as Lyon County staff should be first priority.
